Andrew Arato is the Dorothy Hart Hirshon Professor of Political and Social Theory in the Department of Sociology at the New School for Social Research in New York. He is the author of *Civil Society, Constitution and Legitimacy* (2000) and *Constitution Making Under Occupation: The Politics of Imposed Revolution in Iraq* (2009).

Louis Aucoin is an associate research professor at Tufts University's Fletcher School of Law and Diplomacy. Between 2001 and 2003, while a rule of law adviser at the United States Institute of Peace and then a U.S. Supreme Court Fellow, he advised the Rwandan Constitutional Commission on the development of that country's constitution-making process. In 2002, he served as an adviser in East Timor's constitution-making process, and in 1993, he worked for the Asia Foundation as an adviser to the Drafting Committee of the Cambodian Constituent Assembly that adopted Cambodia's Constitution that year.

Andrea Bonime-Blanc is general counsel, chief compliance officer, and corporate secretary at Daylight Forensic & Advisory LLC, an international compliance advisory firm. She was previously chief ethics and compliance officer at Bertelsmann AG and general counsel of PSEG Global, an international power company. Her publications include Spain's Transition to Democracy: The Politics of Constitution-Making (1987), Hungarian Constitutional Reform and the Rule of Law (1993), and numerous articles on compliance, ethics, and governance topics.

Michele Brandt is director of WSP International's Representation Office in New York City. She formerly was a program manager of East Timor's Constitutional Development Program while working with the Asia Foundation. She was also a full-time constitutional consultant to both the United Nations Transitional Administration in Afghanistan and the Constitutional Commission of Afghanistan.

Allan R. Brewer-Carías is emeritus professor of law at the Central University of Venezuela in Caracas and adjunct professor of law at Columbia Law School in New York. He was a member of the National Constituent Assembly of Venezuela in 1999, and has written extensively on constitutional law and constitutionalism in Venezuela.

Scott N. Carlson is a senior rule of law adviser at the United States Institute of Peace. Prior to joining USIP, he was the director of the Democracy and Governance Practice Group at Chemonics International. From 1997 to 1998, Carlson was a director and legal adviser for the secretariat, supporting and organizing public participation in the Albanian constitution-making process. He has also served as a constitutional legal adviser for USIP in the Democratic Republic of the Congo (2004) and Iraq (2005).

Jill Cottrell retired recently after 40 years of teaching law at the university level. She worked in Nepal from 2006 to 2008 as a consultant with the United Nations Development Programme in the Constitution Advisory Support Unit. She has also advised on various other constitution-making processes.

Hassen Ebrahim was executive director of South Africa's Constitutional Assembly during its 1994–97 term. He previously served as a member of Parliament in the Gauteng Legislature, and as the national coordinator for the African National Congress's Negotiations Commission. He is the author of *The Soul of a Nation: Constitution-Making in South Africa* (1998).

Donald T. Fox is the senior partner of Fox, Horan & Camerini LLP in New York City. He is chairman of the American Association of the International Commission of Jurists, has conducted missions in a number of countries where the rule of law was imperiled, and has written widely on human rights and constitutionalism in Colombia and other countries.

Thomas M. Franck was the Murray and Ida Becker Professor of Law Emeritus at the New York University School of Law and was the director of the Center for International Studies there from 1965 to 2002. Franck served on the U.S. Department of State's Advisory Committee on International Law and served as director of research at the United Nations Institute for Training and Research (1980–82) and as director of the Carnegie Endowment for International Peace's International Law Program (1973–79). Franck, a leading scholar of international law and a legal adviser to many foreign governments, passed away in 2009.

Gustavo Gallón-Giraldo has been the director of the Colombian Commission of Jurists in Bogotá, Colombia, since its creation in 1988. The author of many works on Colombia, he has been professor of constitutional law and human rights at several universities in Bogotá since 1979 and a visiting fellow at Notre Dame University's Kellogg Institute (1998–99). He was also special representative of the United Nations Human Rights Commission for Equatorial Guinea from 1999 to 2002.

Zofia A. Garlicka is currently an attorney with the law firm of Carmody MacDonald in Saint Louis. She is a member of the New York State Bar Association and the Missouri Bar Association. She graduated from the University of Warsaw School of Law (2000) and obtained her LLM degree from the Saint Louis University School of Law (2001). She was vice president of the European Law Students Association, Warsaw Chapter.

Lech Garlicki has been a judge of the European Court of Human Rights since 2002. He previously served as a judge of Poland's Constitutional Court (1993–2001) and as a member of the Legislative Council in the Office of the Prime Minister (1987–92 and 2001–02). Garlicki was a representative to the Polish parliament's constitutional commission, and is a former president of the Polish Association of Constitutional Law. He is the author of many publications in the field of human rights, and has served as an expert for the Venice Commission and for the Organization for Security and Cooperation in Europe.

Yash Ghai is professor emeritus at the University of Hong Kong, where he held the Sir Y. K. Pao Chair of Public Law from 1989 to 2006. Ghai chaired the Constitution of Kenya Review Commission and National Constitutional Conference (constituent assembly), and was adviser to the opposition parties during the constitution-making process in Fiji. His other consultancy work on constitution making has included Papua New Guinea (1973–75), Afghanistan (2002–03), Iraq (2005), and Nepal (2006–present).

Vivien Hart was a research professor in the School of Humanities at the University of Sussex in the United Kingdom. A comparative political scientist, she directed the Sussex Cunliffe Center for the Study of Constitutionalism for ten years and held visiting positions and fellowships in the United States and Canada, including as a senior fellow at the United States Institute of Peace. Hart, an innovator in examining how the process of making constitutions relates to the consolidation of democracy and human rights, passed away in 2009.

Stephen P. Marks is the François-Xavier Bagnoud Professor of Health and Human Rights at the Harvard School of Public Health and senior fellow at the University Committee on Human Rights Studies at Harvard University in Cambridge, Massachusetts. He previously directed the UN Studies Program and codirected the human rights and humanitarian affairs concentration at the School of International and Public Affairs at Columbia University. In 1992–93, he was head of human rights education, training, and information for the United Nations Transitional Authority in Cambodia.

Zoltán Miklósi is an assistant professor at the Central European University, Depart-

ment of Political Science, where he teaches political philosophy.

Laurel E. Miller joined the RAND Corporation as a senior policy analyst in 2009. She has been an adjunct professor of law at Georgetown University and was a senior rule of law adviser at the United States Institute of Peace. She previously held several positions at the U.S. Department of State and the National Security Council. Miller was the deputy U.S. negotiator of a peace agreement for Macedonia, helped negotiate a provisional constitution for Kosovo, and was a member of the U.S. delegation at the Dayton peace conference for Bosnia and Herzegovina. Earlier, Miller practiced law in Washington, D.C., and Brussels.

Jonathan Morrow is international counsel at Hills Stern & Morley LLP, a Washington, DC, law firm, and currently advises the Kurdistan Regional Government of Iraq on constitutional and petroleum matters. He was a senior rule of law adviser at the United States Institute of Peace from 2004 to 2006, working on the constitution of Iraq. Previously, he advised the Asia Foundation and the government of Afghanistan on law reform. Morrow was a legal adviser to the UN Transitional Administration in East Timor, and subsequently to the World Bank, in the negotiation of East Timor's international petroleum treaties.

Muna Ndulo is professor of law and director of the Institute for African Development at Cornell University. He is also Honorary Professor of Law at Cape Town University. He has previously served as public prosecutor for the Zambian Ministry of Legal Affairs, dean of the University of Zambia Law School, Director of the Law Practice Institute in Zambia, political adviser to the United Nations Mission in South Africa 1992–94, Legal Adviser to the United Nations Assistance Mission in East Timor (1999), Legal Expert for the United Nations Mission in Kosovo (2000), and Legal Expert for the United Nations Assistance Mission in Afghanistan (2003).

James C. O'Brien is a principal in The Albright Group LLC, in Washington, DC. Previously, he was a lawyer in the negotiations on the Washington Agreement creating the Bosnian Federation, the Dayton Agreement for Bosnia and Herzegovina, and the Rambouillet negotiations for Kosovo. He was also the special presidential envoy for the Balkans during the Clinton administration.

Keith S. Rosenn teaches law at the University of Miami School of Law and has written widely on constitutional and other legal issues in Brazil. Prior to his academic career, Rosenn practiced law with a Brazilian law firm and worked as a project specialist with the Ford Foundation, helping to establish a graduate legal education program in Rio de Janeiro.

Bereket Habte Selassie is the William E. Leuchtenburg Distinguished Professor of African Studies and Professor of Law at the University of North Carolina at Chapel Hill. Selassie was the chairman of the Constitutional Commission of Eritrea, which led the process of constitution drafting from 1994 to 1997. He has also served as the attorneygeneral and associate justice of Ethiopia's Federal Supreme Court. Selassie is the author of The Making of the Eritrean Constitution: The Dialectic of Process and Substance (2003). Among his many consulting roles, Selassie acted as an external adviser in the Nigerian constitutional review process, September-December 2000.

Anne Stetson is an international lawyer and writer. She is a member of the New York Bar and has written on human rights and constitutional reform in Colombia and other countries.

J Alexander Thier is Director for Afghanistan and Pakistan at the United States Institute of Peace. Prior to joining USIP, he was director of the Project on Failed States at Stanford University's Center on Democracy, Development, and the Rule of Law. From 2002 to 2004, Thier was a legal adviser to Afghanistan's Constitutional and Judicial Reform Commissions in Kabul, where he assisted in the development of a new constitution and judicial system.
